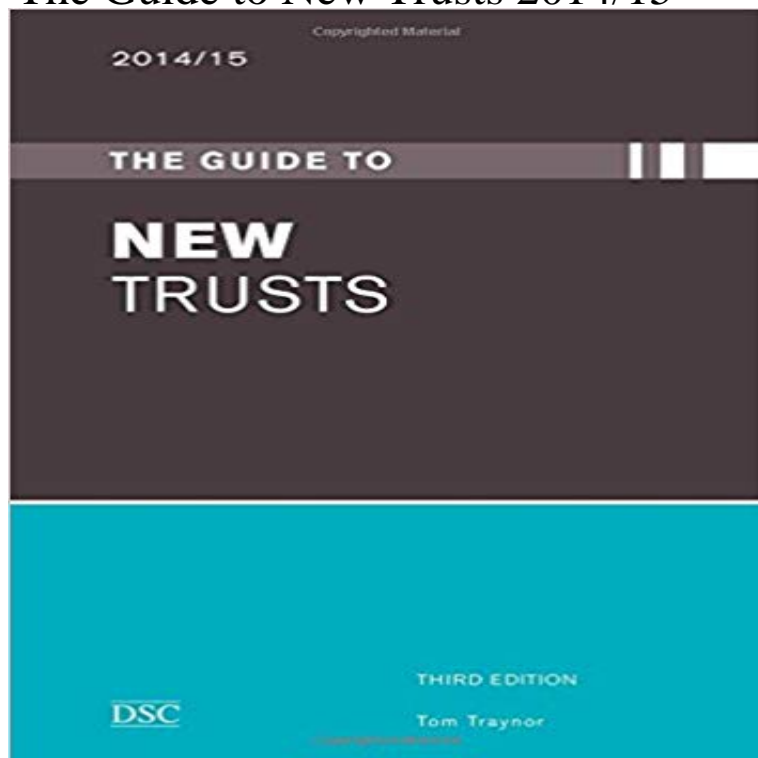


## The Guide to New Trusts 2014/15
