Excerpt: ...shall cut or shut off the current from any consumer so long as such consumer shall comply with all lawful requirements, or without at least two days notice in writing to such consumer, stating the reason for such action: Provided, That such consumer shall deposit the amount of any disputed bill with the city assessor and collector and apply for an inspection and test of his meter within five days after the receipt by him of the disputed bill for electricity, and the city electrician shall inspect said meter within five days thereafter; and nothing in this section shall be construed as prohibiting any such person from cutting or shutting off the supply of electricity when a consumer is in arrears in the payment of any bill therefor for fifteen days. 68--7.
