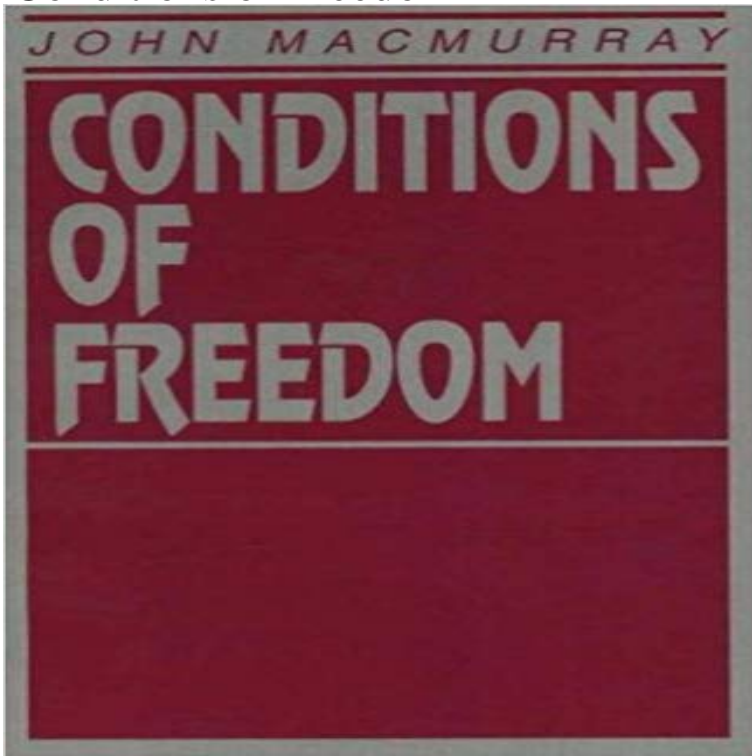


Conditions of Freedom
