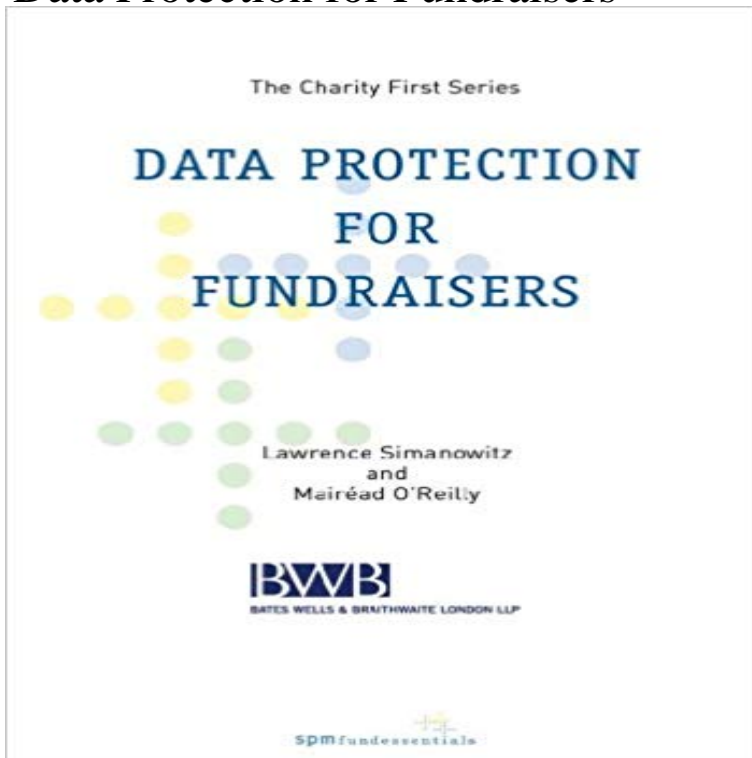


# Data Protection for Fundraisers
