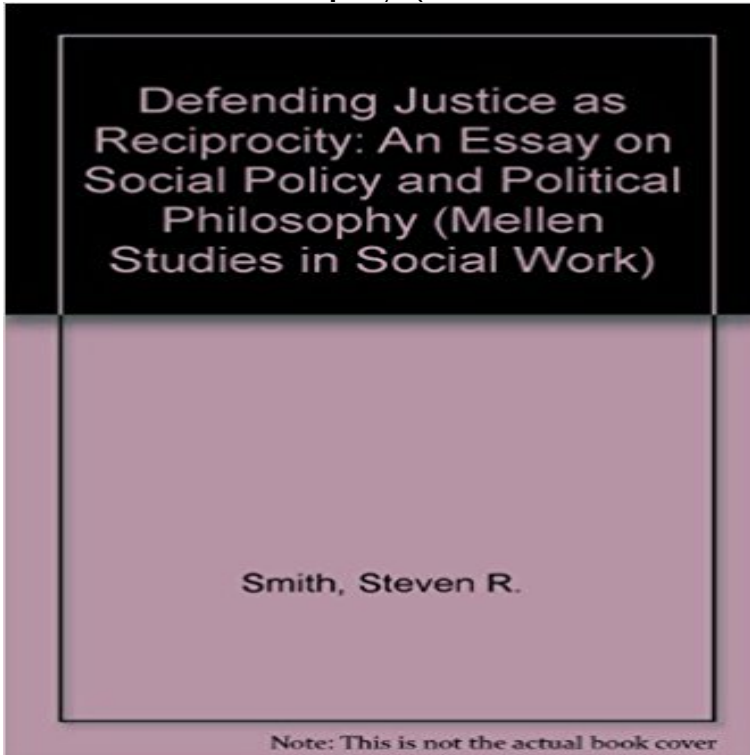


Defending Justice As Reciprocity: An Essay on Social Policy and Political Philosophy (Mellen Studies in Social Work, V. 6)
