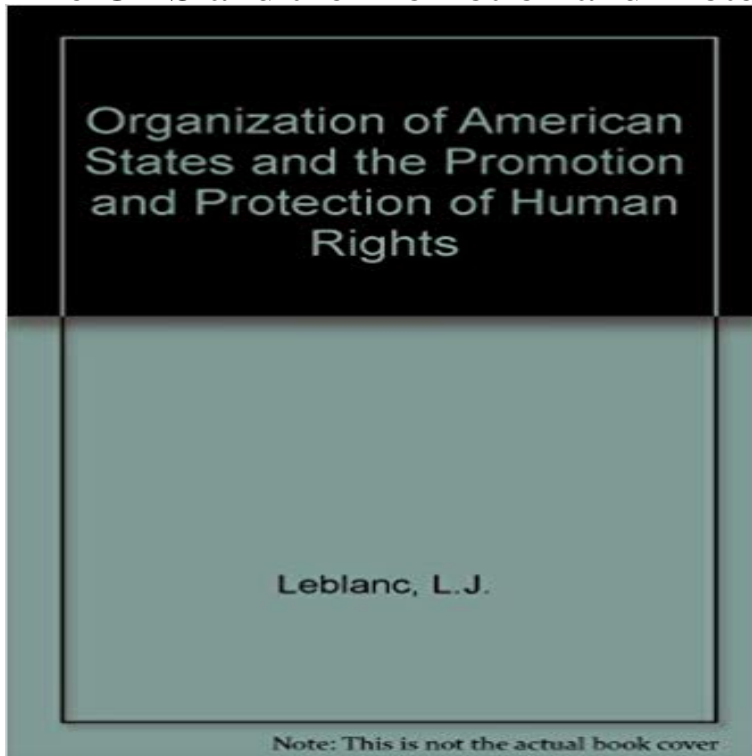


The OAS and the Promotion and Protection of Human Rights
