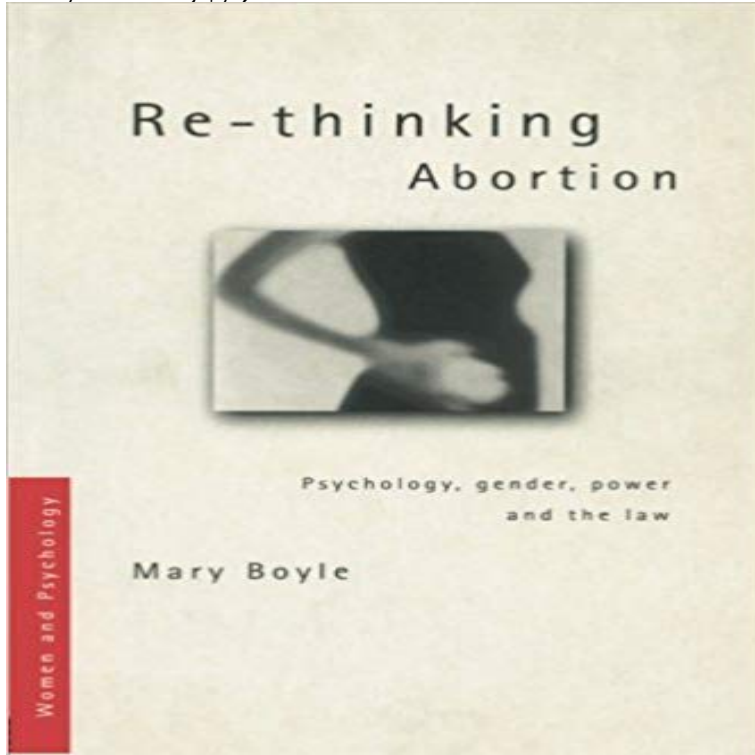


Re-thinking Abortion: Psychology, Gender and the Law (Women and Psychology)
